RELATIVE TO THE BORROWING AND FINANCING OF A TWO-MILLION AND FIVE-HUNDRED THOUSAND DOLLAR AND NO CENTS (\$2,500,000.00) LOAN FOR THE DESIGN AND CONSTRUCTION OF A MULTI-PURPOSE CENTER IN THE MUNICIPALITY OF CHALAN PAGO-ORDOT; TO BE CONSTRUCTED ON LOT 3458-R1, UNDER THE ADMINISTRATIVE JURISDITION OF THE CHALAN PAGO-ORDOT MAYOR'S OFFCE.

WHEREAS, under §51402, Title 10, Guam Code Annotated, Chapter 51 (10 GCA Ch. 51); the village of Ordot was designated as a "Host Community" and became the recipient of Host Community Premium (HCP) funds accessed, collected, and disbursed quarterly, by the Guam Solid Waste Authority (GSWA) in the amount of no-less-than One-Hundred and Fifty-thousand dollars and no-cents (\$150,000.00), annually; and that these funds are to be used for the exclusive benefit of the Municipality of Chalan Pago-Ordot; and

WHEREAS, under §51404, 10 GCA Ch. 51, the Municipal Planning Council (MPC) of Chalan Pago-Ordot shall determine the projects to be funded for our community, from these HCP funds; and

WHEREAS, with the successful approval of a federal grant under the Office of Economic Adjustment (OEA), Department of Defense (DoD) to assist with the funding to construct a Multi-Purpose Center on Lot 3458-R1, under the jurisdiction of the Municipality of Chalan Pago-Ordot; the Mayor's Office and Municipal Planning Council is taking action to move forward in borrowing \$2,500,000.00 to complete their matching share of Three-Million dollars and no-cents (\$3,000,000.00) for the "design and construction" of this new facility; and

WHEREAS, under MPC Resolution 2020-04, the council has already budgeted and set aside fivehundred thousand dollars and no-cents (\$500,000.00) from their available on-hand funds that will be combined the funds borrowed in accordance with this resolution to complete the \$3,000,000.00 being obligated towards the design and construction of this new Multi-Purpose facility; NOW THEREFORE BE IT

RESOLVED, that the Chalan Pago-Ordot Municipal Planning Council approves the borrowing and financing of a loan amount of no more than two-million, five-hundred thousand dollars and no-cents (\$2,500,000.00) that will be procured with the assistance of the Guam Economic Development Authority (GEDA) for the specific use in the design and construction of a new Multi-Purpose Center that is to be constructed on Lot 3458-R1; and be it further

RESOLVED, that the Mayor is given the approval and authority to sign any and all loan documents to initiate the borrowing of a \$2,500,000.00 loan and is authorized to obligate NO_MORE than one-

RELATIVE TO APPROVING A BUDGET OF THREE-MILLION DOLLARS AND NO CENTS (\$3,000,000.00) FOR THE DESIGN AND CONSTRUCTION OF A MULTI-PURPOSE CENTER IN THE MUNICIPALITY OF CHALAN PAGO-ORDOT; TO BE CONSTRUCTED ON LOT 3458-R3, UNDER THE JURISDITION OF THE CHALAN PAGO-ORDOT MAYOR'S OFFCE.

WHEREAS, under §51402, Title 10, Guam Code Annotated, Chapter 51 (10 GCA Ch. 51); the village of Ordot was designated as a "Host Community" and became the recipient of Host Community Premium (HCP) funds accessed, collected, and disbursed by the Guam Solid Waste Authority (GSWA), and that these funds are to be used for the exclusive benefit of the Municipality of Chalan Pago-Ordot; and

WHEREAS, under §51404, 10 GCA Ch. 51, the Municipal Planning Council (MPC) of Chalan Pago-Ordot shall determine the projects to be funded for our community, from these HCP funds; and

WHEREAS, during the seven plus (7+) years of receiving these HCP funds, the MPC developed a Chalan Pago-Ordot Mayor's Complex Plan, which identifies corresponding capital improvement projects that these HCP funds would be allotted towards; and.

WHEREAS, this Mayor's Complex Plan included the construction of a Multi-Purpose Center on Lot 3458-R3, under the jurisdiction of the Municipality of Chalan Pago-Ordot; and, where our community center, Jose U. Atoigue Baseball Park, and our municipal basketball & tennis courts are currently located and, is the planned location of a new Mayor's Office that was advertised for bid in February, 2020; and

WHEREAS, the allotment of our current and future collection of HCP funds in financing a Multi-Purpose Center is limited to a budget of three-million dollars and no-cents (\$3,000,000.00), with the balance of the "total" Design & Construction costs being sought after in the form of a matching grant(s), which we have <u>pursued</u> over the past five (5) years, <u>unsuccessfully</u>, through meetings and/or grant applications with the Guam Housing Urban Renewal Authority (GHURA), the Guam Economic Development Authority (GEDA), and the U.S. Small Business Administration (US-SBA); and

WHEREAS, the MPC Certifies that "unobligated" HCP funds in excess of five-hundred thousand dollars (\$500,000.00+) is currently available, for the allotment of funds to expend on capital improvement projects which support the Mayor's Complex Plan and, that these HCP funds is currently held in accounts under the village's MPC Revolving Funds, on behalf of the Municipality of Chalan Pago-Ordot and established in accordance with §40135, 5 GCA Ch. 40; NOW THEREFORE BE IT

RESOLVED, that upon approval of the loan amount authorized in this resolution, the Mayor is directed to set aside an annual allotment of approximately <u>one-hundred and forty-three thousand dollars and no-cents</u> (\$143,000.00) from the annual HCP Funds received; and apply these allotted funds, towards the repayment of a low-interest, municipal loan, over a period of no less than twenty-five (25) years and no more than thirty (30) years, for the repayment of an approved <u>two-million</u>, <u>five-hundred thousand dollars and no-cents</u> (\$2,500,000.00) loan that is specifically used for the construction of a Multi-Purpose Center on Lot 3458-R3; and be it further

RELATIVE TO RECOGNIZING AND CONGRATULATING MONSIGNOR DAVID I.A. QUITUGUA FOR HIS FIFTY-SIX (56) YEARS OF FAITHFUL SERVICE AND DEDICATION TO THE PEOPLE OF CHALAN PAGO-ORDOT, THE CATHOLIC COMMUNITY OF GUAM, AND FOR HIS PASTORAL LEADERSHIP TO OUR ISLAND COMMUNITY.

WHEREAS, David Ignacio Arceo Quitugua was born on February 26, 1936 to his loving parents †Ignacio Perez Quitugua and †Rosa Santos Arceo Quitugua and, is the third of nine (9) sons, who spent his first year in Asan where his father was the principal of the village's elementary school; and

WHEREAS, the following year, in 1937, his father was appointed as Principal of Talafofo Elementary School, where the family moved to before the war; and, where David was only five (5) years old at the start of World War II, in which he recalls the hardships and horrors of war and the relocation of his family to the Manenggon Concentration Camp, with the return of U.S. military forces to Guam, during the Liberation of our island; and

WHEREAS, with the end of the war, David resumed his education at Talafofo Elementary School, then transferred to Sinajana Elementary School; before receiving the assistance of Father Alvin LeFier, pastor of St. Francis Church in Yona, who helped with his enrollment at St. Francis School and where he remained until his promotion from 8th grade in 1951, followed by his acceptance to the Father Duenas Minor Seminary which included high school and junior college curricula and, was the start of his formal program towards the fulfillment of his calling to the priesthood; and

WHEREAS, with the recommendation of the late Archbishop Felixberto C. Flores, Chancellor of the Vicariate of Guam at the time, David was recommended for and awarded a six-year scholarship to St. John Major Seminary in Boston, Massachusetts, upon graduating from Father Duenas Minor Seminary; and, after completing his Seminary education and preparation at St. John's Major Seminary, David returned home in December 1963 and was ordained as a diocesan priest on February 11, 1964, in the Dulce Nombre de Maria Cathedral by the late Bishop Apolinaris Baumgartner, First Ordinary Bishop of Agana; and

WHEREAS, Father David's first assignment was to the Agana Cathedral, as assistant to the then Monsignor Felixberto C. Flores and, assigned the Priest-in-Charge of the Immaculate Heart of Mary Church in Toto; and after shepherding the parishioners of Toto, Father David was assigned to St. Anthony & St. Victor Church in Tamuning as assistant to Father Vicente Martinez from 1965-1969; and while at St.

Anthony, he served as the chaplain at Guam Memorial Hospital and Priest-in-Charge of St. William Church (a.k.a. Blessed Diego Luis de San Vitores) in Tumon; and

WHEREAS, during his pastoral duties in Tamuning and Tumon, Father David also served as a member of the Juvenile Justice Advisory Committee and taught at the Academy of Our Lady of Guam and Father Duenas Memorial School; and during this period, he also became a full-time student at the University of Guam, taking graduate courses in Secondary Education and, in 1969, Father David became the first Chamoru to earn a master's degree from the University of Guam; and

WHEREAS, after graduating from the University of Guam, Father David was accepted at the Catholic University of America, Washington, D.C., for graduate studies in sociology; and with his education in sociology, he worked for the Department of Public Health and Social Services as Supervisor of the Child Welfare Program from 1971 to 1975 and simultaneously served as the Pastor of Nuestra Senora de los Aguas Church in Mongmong and a part time instructor on social issues at the University of Guam; and

WHEREAS, in May 1975, he was asked by †Archbishop Flores to be a member of the United States Catholic Conference, to head the resettlement program for more than three-thousand Vietnamese Refugees on Guam who were homeless and jobless and a month after sponsoring and caring for these Vietnamese refugees, Father David was appointed as the new pastor of St. Anthony & St. Victor Church in Tamuning and served in this assignment from June 1975 to 1990; and

WHEREAS, as the pastor of St. Anthony, he helped build the parish Rectory and the Adoration of the Blessed Sacrament Chapel and was instrumental in starting the Divine Office Prayer Group; and

WHEREAS, in 1979, he saw the need to address the social gaps on Guam and founded the Catholic Social Service for our people and served as the Executive Director of Catholic Social Service on Guam from 1979 to 1990, which now employs over 200 people and is the largest non-profit organization on Guam, with an annual budget of over 5-million dollars, now under the directorship of Diana B. Calvo; and

WHEREAS, Father David assisted †Bishop Tomas Camacho in setting up the Catholic Social Service in the diocese of Chalan Kanoa, Saipan, now known as Karidad and in 1981, Father David and the Good Shepherds Sisters founded the Alee Shelter for Abused Women and Children, which is under the umbrella of the Guam Catholic Social Service; and

WHEREAS, among his other Civic service, Father David served for seven (7) years as a member of the Guam Housing Corporation Board during the Governorship of †Carlos Camacho and †Ricardo J. Bordallo; as a member of the Pardon Review Bord under Gov. Carl Gutierrez; and he served as Director of Vocations for the Archdiocese of Agana and as member of the Archdiocesan Consultors under the late Archbishop Felixberto Flores; and

WHEREAS, while fulfilling his responsibilities with the Archdiocese of Agana and the people of Guam, he continued his graduate studies during his summers and earned his master's degree in Pastoral Counseling and Religious Education from Boston College, Massachusetts in 1983; and

WHEREAS, in 1990, Father David was granted a sabbatical leave and attended Marquette University in Milwaukee, Wisconsin, where he earned a master's degree in Journalism in May 1992 and subsequently went on to assist Bishop †Tomas Camacho, Diocese of Chalan Kanoa in Saipan in the founding of a Diocesan newspaper, "The North Star", where he served as their first Executive Editor and fulfilled his assignment of Vicar General for their diocese; and

WHEREAS, returning to Guam in 1993, Father David was appointed as the Pastor of San Juan Bautista Church in Ordot, where he led the parishioners in raising funds to build the San Juan Bautista Catechetical Building, which was completed in 1996; raised funds for the needed renovations and improvements to the Prayer Garden, which included the construction of a new chapel and a new pavilion for social gatherings; and in 2003, shepherd the expansion and renovation of the church to accommodate the growth of our parish community; and

WHEREAS, throughout his service to the people of Guam and in recognition for his outstanding contributions and leadership, Father David was given the Distinguished Humanitarian Award from the United States Catholic Conference, for his service to the Vietnamese Refugees; in 1980 he was chosen as Social Worker of the Year by the Guam Association of Social Workers; he was recognized by the Pacific Daily News as one of the "Ten Who Made a Difference" on Guam; in 1990 he was awarded an Honorary Doctorate Degree from the University of Guam; in 1996, he was named "Islander of the Year" by Latte Magazine; and on 10 May 2006, was awarded the title of Monsignor while serving as the pastor of San Juan Bautista Church in Ordot; and

WHEREAS, for his fifty-six years of service as a priest and in celebration of Father David's eighty-fourth (84th) birthday, the people of Chalan Pago-Ordot offers their best wishes and deepest appreciation to Monsignor David I.A. Quitugua for his years of dedicated ministry and love for the people of Guam and most especially, for his service as Pastor and now, Pastor Emeritus to the parishioners of San Juan Bautista Catholic Church in Ordot; NOW THEREFORE BE IT

RESOLVED, that the Chalan Pago-Ordot Municipal Planning Council gives recognition to Monsignor David I.A. Quitugua for his outstanding contributions to the community and the people of Guam and commends him for his fifty-six years of faithful service as a diocesan priest and his continued dedication to our community as Pastor Emeritus of San Juan Bautista Catholic Church, as the parish celebrates his anniversary of ordination and his eighty-fourth birthday; and be it further
