I. **CALL TO ORDER:** *President* Mayor Jesse L.G. Alig called the meeting to order at 10:04 a.m.

- Fourteen (14) members present at time of roll call. A quorum was not established.**
- III. NATIONAL ANTHEM / GUAM HYMN**
- IV. GUEST SPEAKER – Annette Aguon, Bureau Disease Communicable Administrator, DPHSS (GUAM INNOVATIVE READINESS TRAINING):** Will be working in conjunction with the U. S. Department of Defense and other branches of military to assist with the medical mission that will take place on July 31 – August 3, 2024 and August 5 – August 8, 2024. Mayor Anthony Chargualaf made the motion to cater the hosting and pay for the dancing entertainment. Mayor Rudy Paco seconded the motion. Motion carries.
- V. APPROVAL OF JUNE MINUTES**  
*Motion made by Mayor Vicente Taitague and seconded by Mayor Dale Alvarez. No discussions or objections. The motion carries.*
- VI. APPROVAL OF TREASURER’S REPORT**  
*Motion made by Mayor Robert Hofmann and seconded by Mayor Johnny Quinata. No discussions or objections. The motion carries.*
- VII. PRESIDENT’S REPORT**  
**BODY ACHIEVED QUORUM**  
Mayor Alig officially announced that we have a quorum. Mayor Bill Quenga, Mayor Robert Hofmann, and Vice-Mayor Peter John Benavente has joined us.
- NON-APPROPRIATED FUNDS (NAF) / APPROPRIATED FUNDS (AF) / AMERICAN RESCUE PLAN ACT (ARPA):** President Alig urges submission of financial reports via email and in person to DRT (Department of Revenue & Taxation), with the Mayors’ Council included for posting. A district has not submitted its last quarter’s report, and the OPA (Office of the Public Auditor) is aware of this. The reports are auditable and must be filed by July 15. If any questions arise, please contact Ms. Mary or someone who assists with accounts.
- He also reported that the Council has settled GPA (Guam Power Authority) and GWA (Guam Waterworks) arrears and is working on funding community maintenance workers for hazardous pay until December 2024. The remaining lapses, around 20,000 will be distributed equally to all workers before September 30<sup>th</sup>. Previously, there were 4 million lapses, and BBMR (Bureau of Budget and Management Research) wouldn’t allow ARPA (American Rescue Plan Act) use or additional funding until all lapses are spent. Once the lapses are calculated, the remaining ARPA balance can be requested. The Council is working diligently to ensure everyone receives the necessary cash.
- VIII. COMMITTEE REPORTS – Boards and Commissions / Standing Committees**  
**Mayor Savares** reported that GDOE (Guam Department of Education) is requesting a letter from Mayor Dale Alvarez indicating the intent to use JP Torres campus for community activities, such as a learning resource center and office. Also, that the superintendent would like an updated resolution for Chief Brodie Elementary to be converted into a Middle School. Stakeholders have not had meetings or access to stakeholder surveys. All mayors are advised to involve the community in answering questions and hold community meetings to discuss the decommissioning of schools, such as Inarajan Elementary and Oceanview Middle School, to prevent further decommissioning.
- IX. UNFINISHED BUSINESS**



**USER FEE SCHEDULE** - The President seeks Council legislation for next meeting, adoptable by legislature, with final rationale provided to mayors and vice mayors before voting.

**80<sup>th</sup> LIBERATION PLANNING** – Games of Chance was approved by the Governor. We have to ensure the laws for Games of Chance are followed. The President announced a reminder about the 80<sup>th</sup> Liberation Queen Coronation to be held on Sunday, July 07, 2024.

**X. NEW BUSINESS**

**LABOR DAY / EMPLOYEE APPRECIATION** – Mayor Melissa Savares proposed an indoor employee appreciation event on Labor Day for various offices, including Department of Labor Employees, Mayors' Council of Guam Employees, Recreation Leaders from Typhoon Mawar, and SCT Workers and Community Workers, chaired by Mayor Louise Rivera. Mayor Hofmann offered to take care of the pins of service years.

**Recycling Revolving Fund** – The President acknowledged appeals from Mayor Melissa Savares and Mayor Louise Rivera, but announced no funding for junk vehicle removal. The President faced issues with recycling centers and expired vendor certificates, leading to provisional extensions from Guam Environmental Protection Agency. An alternative strategy with a sole supplier was abandoned due to temporary permits.

**Executive Director Position** – President Alig announced that we are still pending an appointment of an Executive Director. A motion was then made by Mayor Dale Alvarez to appoint MCOG President, Mayor Alig as acting Executive Director in the meantime until the position is officially filled. Motion was seconded by Vice Mayor Albert Toves. Motion carries.

**XI. ANNOUNCEMENTS:**



The director of energy is also asking for information on the solar lighting project. The President also mentions the importance of having two staff or representatives per office trained in suicide prevention.
