A.	The Executive Director announced that the MCOG central office is in receipt
	of the Memorandum of Agreement (MOU) from Guam Environmental
	Protection Agency (GEPA) regarding the Revolving Fund and she will review
	for approval and signature by the end of the week.
B.	The Executive Director announced that the Mayor's and Vice Mayor's must
	provide a list of staff they will be retaining and/or releasing with an attached
	resignation letter and a memorandum in order to receive the lump sum pay
	outs. Incumbent Mayor's will not need to provide anything. Mayor' and Vice
	Mayor's who are separating are asked to submit their clearance form as
	required by Department of Administration and Government of Guam
	Retirement Fund.
C.	The Executive Director reiterated that the supplemental budget of 3.6
	million is dedicated to salaries that was not covered under the original
	budget which mainly for the community maintenance workers. The
	remaining nine hundred thousand will be equally divided amongst the 19
	villages as agreed upon which is roughly about forty-seven thousand each to
	operate. One of the common questions asked is when will it given to the
	districts, the Executive Director is looking at January 2025.
