#### III. NATIONAL ANTHEM/GUAM HYMN

- IV. APPROVAL OF DECEMBER MINUTES Mayor Vicente Taitague made the motion to approve and seconded by Mayor Melissa Savares. No discussions or objections. The motion carried.
- V. APPROVAL OF TREASURER'S REPORT Mayor Dale Alvarez made the motion to approve the reports and seconded by Mayor Anthony Chargualaf. In discussion, upon reviewing the Guam Island Fair report, Mayor Savares queried if Council could begin preparations for *Liberation*. The president responded yes. No discussions or objections. The motion carried.
- VI. EXECUTIVE DIRECTOR'S REPORT

**GUAM EDUCATION BOARD** – ED reported the new acting superintendent is Frank Cooper-Nurse for 30 days.

AMERICAN RESCUE PLAN ACT (ARPA) FUNDS FOR HEAVY EQUIPMENT – Districts should already have received their purchase orders. If there's been some purchase orders or requisitions that mayors still have not received, email ED directly.

awaiting EPA's approval of the operations plan. The MOU is still at the attorney general's office and then to the governor for signature.

QUARTERLY REPORTS – Appropriated and non-appropriated fund reports are due by January 13.

VILLAGE GROWTH DATA FOR CITIZEN CENTRIC REPORT – A few Districts have started to submit their data. It will then be compiled by the council in order to send to the public auditor.

ETHICS TRAINING COMPLIANCE – ED reminded mayors of the requirement by the Ethics Commission to have all employees go through the training. ED stated, "As soon as you know that you can send your employees or have your employees do this online, please do so, especially for those that you have just hired within the last six months."

**MUNICIPAL PLANNING COUNCIL** – Members can only serve for two years until the mayor re-appoints them, which must be done this month since the second two years of their term have just begun. A municipal planning council requires a minimum of 10 members. Simply due to population, a District can get more but at the very least have 10 members chosen to serve as a MCP member.

**SCHEDULE OF ANNUAL EVENTS** – Many organizations, including the Guam Visitors Bureau, have asked the Council to provide a calendar of what is happening in the villages so that they can also plan if they are able to support or other groups can arrange their activities around their events. ED asked mayors to send in their schedules. These events will also be posted on Council's website.

**VEHICLES** – From the last report, ED stated that the purchase order had already been delivered to the vendor. Council is just waiting for the delivery of the vehicles. Mayors would be notified once Council learns that it is prepared for delivery.

**NATIONAL OFFICE SUPPLY** – MCOG Admn. is actively looking at invoices and reconciling everything. Several districts are up to date. Admin. has seen invoices as far back as 2013 and 2014 that have been paid, but a new accountant at NOS is combing through their records and pulling out whatever she sees not paid. Admn. has documents showing they're paid.

There are delays at Dept. of Administration. Admin. found out that there were many invoices that are there that have not been posted. Joann Charfauros is being borrowed by DOA a couple of days a week in the afternoon to help sort out all the invoices and post them. Admin. is working to release the Districts as quickly as possible in order to resume purchasing from NOS.

**STRAY ANIMAL ROUND-UP (SARU)** – Mayor Rudy Paco reported GAIN is waiting on the blueprint for the additional kennels so they can bid it out.

#### VIII. UNFINISHED BUSINESS

#### IX. NEW BUSINESS

- A. **EXECUTIVE OFFICERS SWEARING IN** *President* stated this was added to the agenda in the event that any expenditures needed to be approved, but since the swearing-in ceremony was held this morning, he believed that was adequate and that no additional ceremony was required. There were no objections.
- B. **BOARDS AND COMMISSIONS TERM EXPIRATION/APPOINTMENTS** *President* stated if a mayor or vice mayor is a member of a particular board or commission, to let him know via email by Friday of this week if they would like to continue serving on the board or commission or resign from it so that he can make the necessary appointments. During the regular meetings, each board and commission representative is asked to provide an update from their committee so that the council is informed.
- C. MCOG RESOLUTION 2022-17-01 The resolution was resent to council members by the president. He hoped that everybody remembered the resolution this council had passed concerning the disposal of nuclear waste in the Pacific Ocean. The language in the resolution from Council echoed that of the AMIM and backed the AMIM's actions.

The people to whom the resolution was to be sent received it and the Council General of Japan was one of them. He requested a meeting with the president and ED. It was discussed that the resolution was perhaps erroneous because there were some untruths. The Council General came with a document that the president sent to everyone, and it was regarding ALPS treated water. Council General referenced the research's sources in that document.

The president's concern is that in the AMIM resolution, it says that there is no study, there's no research, there's no monitoring. But in what is presented by the Japan government to us locally, there is monitoring. There was research. He expressed his apologies for not understanding it thoroughly and just agreeing without researching it on his own. He asked if there is a motion to rescind the MCOG resolution.

Mayor Robert Hofmann made the motion to rescind the resolution presented by the Mayors' Council of Guam to the Japan government and no further action after that. Seconded by Mayor June Blas.

In discussion, *President* stated, "I would like to say that I don't, in keeping with supporting our neighbors in the CNMI, I think we certainly can say that we maybe not support the work of the Japan government, but say that we do want to make sure that there is constant monitoring and that the reports of that monitoring are given to us or posted on their website so that there is constant monitoring. Because I can safely say that even us on Guam, we are also very concerned about what goes on around our waters and our shores and we are in relation to the federal government as well. We don't want to give everything but we want to be amicable. We want to have a better relationship with those that provide some

service to us. But of course, monitoring and making sure that regulations are followed are very important. The other thing that is noted on this report from the Japan government is the power plant meets international standards and WHO standards."

Mayor Jessy Goque stated, "The information we received from our consulate general raises some concern as to how this came about at our AMIM meeting in the first place. I'm just wondering whether or not there was an effort to go back to our AMIM sisters and brothers to share with them the information we received from the Consulate General and get their take and potential rebuttal with regard to the information we've received and what really triggered the whole intent of driving this resolution. We got a response from the Japanese government, but by the same token we need to give our brethren who raised this at our.AMIM meeting the ability to give a response to the information that we in fact got from the consulate general as well. In fact, maybe that's what we did in the first place, is we didn't get feedback from the Japan government because there was a push to try to meet with Japan officials before February on this issue. As a result of that timeline that was set at the AMIM meeting, we kind of rushed into adopting a resolution as opposed to looking at and trying to address this issue that was raised in a more methodical manner. Maybe we need to kind of step back and do the methodical process of giving our colleagues up north an opportunity to provide input on the information that was received before we were quick to put to our resolution that we have already put out there."

Mayor Melissa Savares agreed with Mayor Gogue. She said, "They got their information from United Nations and said that this is what's going to happen. So, of course, they informed the different elected councils from the three islands, got together, and worked with that information, but what United Nations is saying is, oh no, they're just going to release it without citing the research that has been done. So I think that what we can do is cite the research that we were given when we rescind this resolution."

President stated, "I'm inclined to support the motion simply because it says clearly that there's no study and no monitoring. They didn't mince words. It's clear that there was none. But what is being presented to us by the Japanese government is that there is research and that there are controls. So I understand where Mayor Gogue and Mayor Melissa are coming from as far as understanding what the CNMI would like us to support. But at the same time, we have an obligation too, on our end to make sure that what we issue is also congruent, it just should be congruent to what is actually happening. If at any time anyone wants to bring this up, please let us know and we can take up a new resolution at our regular meeting and we can make that part of the agenda."

All in favor. None opposed. The motion carried.

#### D. MUNICIPAL EVENTS 2023

## 1. List of Festivals, Annual Events

President conveyed to the Body to inform the Council of all significant events in their village so that they could be shared with the media and on the website. He reminded the mayors to adhere to their reporting requirements for those events.

# 2. 79<sup>th</sup> Liberation Festivities

Because it's a big discussion, the president called for a separate meeting rather than during regular meetings. There were no objections. He requested that a committee meeting be called following the special meeting on January 18 at 1 p.m. to discuss some initial plans as to how to proceed with liberation.

## X. ANNOUNCEMENTS

A. **JOINT REGION MARIANAS INVITATION** – Read Admiral Benjamin Nicholson, Commander spoke briefly and invited the mayors and vice mayors to a briefing on threats in the region at 11 am Wednesday, January 18. This briefing will be given by Indo-Pacific Command (INDOPACOM) assisted by JRM at headquarter on Nimitz Hill.

The special meeting for Council was set for that day, therefore Mayor Hofmann motioned to move from January 18 to January 17 to accommodate the admiral's invitation and Mayor Savares seconded the motion. No discussion. The ayes have it.

President conveyed to the Body of rescheduling the Liberation meeting.

- Mayor Savares announced the presence of Vice Mayor Marian Lujan from Guimbal, Iloilo who is here for her husband, senator-elect Jesse Lujan's inauguration. Between Barrigada, Dededo, and Hågat there was a sister-city signing years ago.
- President recognized and gave the floor to special assistant of municipal affairs Robert Lizama. Mayor Hofmann queried about the status of the streetlight installations. Mr. Lizama stated there have already been documents that have been forwarded to GPA, and they are waiting for them at the request of the lieutenant governor to see if they're able to provide an additional team to assist with the new streetlight installation. Mr. Lizama feels what needs to be addressed in a separate meeting, is trying to standardize the new streetlight installation requests, because some mayors are still utilizing a document or a form that is a form that is used by DPW to transmit to GPA for the actual assessment of these streetlight requests. Mayor Taitague queried about village street paving. Mr. Lizama responded that there have been street repairs that are ongoing around the island.
- President recognized and gave the floor to Rob San Agustin, program director with OHAPP. Mayor Hofmann queried for an update about the point-in-time count for the homeless. Mr. San Agustin conveyed that the count is Friday, January 27. Salvation Army in Tiyan will serve as the headquarters and will open at 3:30 am. From there, the team will be assembled. They have conducted assessments of the homeless at 185 locations. On that day, they will go to all the villages. Compared to how it was run during COVID, this will be more of the standard point in time cap.
- President recognized and gave the floor to Therese Hart, special projects coordinator with the Office of Infrastructure Policy & Development. Their office sent out a letter via email to all the mayors on December 13 about improving broadband internet connection in all the villages. Their office wants to share a map that the FCC sent them and as they looked at the map, they noticed that several states and territories also had issues with it because it did not adequately represent its constituents. some villages were overrepresented like Hagatna, and then others were very underrepresented. The reason why they need to do this is that they want to challenge the FCC and to give them an accurate representation of the entire island. With the approval from ED, their office will use the Mayors' Council conference room to meet with two to three mayors in the morning and in the afternoon to show the map and ask the mayors to show them places in their villages that are not covered.

# XI. ADJOURNMENT

President thanked Council members and adjourned the meeting at 11:56 am.


