- III. APPROVAL OF AGENDA Mayor Melissa Savares made the motion to approve and seconded by Vice Mayor Jessie Bautista. All in favor. The motion carried.
- IV. APPROVAL OF DECEMBER MINUTES Mayor June Blas made the motion to approve subject to correction and seconded by Mayor Allan Ungacta. All in favor. The motion carried.
- V. APPROVAL OF JANUARY TREASURER'S REPORT Mayor Melissa Savares made the motion to approve the report and seconded by Mayor June Blas. No discussion or objection. The motion carried.

VII. EXECUTIVE DIRECTOR'S REPORT

ARPA FUNDS – Initial release allocating \$8.3M. Because discussions may take another 30 minutes, ED requested this item be moved to *New Business*, at the decision of the body go into executive session to discuss, and then move back out into the regular meeting to vote.

COVID-19 DIFFERENTIAL PAY – With the ARPA funds, BBMR released \$190,000 plus and Council was able to pay five pay periods.

ISLANDWIDE ENVIRONMENTAL CLEANUP PROGRAM; RRF — Memorandum of Agreement was signed by Office of the Attorney General two days ago and is with the governor for her signature then to Dept. of Administration to upload into Council's account.

ED had sent a legal opinion September 2021 regarding abandoned/junk vehicles from public easements. Council would have to work with the AGO and the legislature to amend the public law. Until the governor's office finds a suitable designated place for an impound lot, Council may ask GEPA to allow funds to contract a junkyard, tow truck lot or somebody to use their lot for the time being.

QUARTERLY REPORTS – Due by the January 10 for expenditures under the Village-Maintenance-Beautification-Public Safety Programs (VOMBPS) and Non-Appropriated Fund. It is expected all to be compliant so that they are posted on Council website.

QUARTERLY BREAKFAST MEETING WITH GOVERNOR AND LT. GOVERNOR – In wanting to keep everything COVID safe the executive officers felt that a restaurant was able to serve properly and not have any issues. Four Hundred Fifty dollars (\$450) was initially approved to host alternating with the governor and the MCOG. Because Council would spend more, *President* asked for a motion to spend no more than Seven Hundred dollars (\$700). Mayor Robert Hofmann made the motion and seconded by Mayor Anthony Chargualaf. In discussion, *President* commented that the officers have selected two (2) menu items, one with meat and one that is a vegetarian breakfast and choice of beverage. No further discussion or objection. Motion carried. The meeting is scheduled for 7:30 a.m., January 12 at Three Squares Restaurant, Tamuning.

VIII. COMMITTEE REPORTS

1. BOARDS AND COMMISSIONS - No reports.

2. STANDING COMMITTEES

LEGISLATIVE AND FINANCE COMMITTEE ON BILL NO. 234-36 — Relative to establishing a public private partnership for the installation of video security cameras in public areas. Sent to *President* by Senator James Moylan for consideration. The committee will share the bill with Council members to look at and see to either send a letter of support or send comments to Senator Moylan.

Mayor Jessy Gogue queried if Senator Moylan's office engaged with companies that could provide this kind of service and whether or not it is viable to them to establish a public private partnerships for CCTVs.

There has not been a committee meeting but *President* will let the Body know when it is going to be scheduled and invite the senator to talk about his proposal.

When the meeting is scheduled, Mayor Gogue expressed his participation and to ask the question directly to the senator.

USDA WILDLIFE SERVICES FERAL SWINE TASK FORCE – *President* reported having another meeting with a group from the Southern Soil and Water Conservation District and Animal and Plant Health Inspection Service (APHIS). The plan is to purchase traps that USDA is using and hopefully assist mayors in the south and central areas to trap feral pigs There are six in the south and six in the north, and are active but is not enough to curb the issue. A meeting is scheduled the end of the month to talk about the progress on the ordering of the additional six traps.

STRAY ANIMAL ROUND UP (SARU) – *President* reported that a stray dog bit a resident in Piti. *President* and Mayor Paco had met with the deputy chief of staff and the director of agriculture many months ago about the situation and they had asked that GAIN continue to follow the agreement, which is to keep the dogs for a certain amount of time and then do what they needed to do after that time was up. There is frustration. Mayors continue to talk about this but there is no fruition in these discussions.

Committee chair, Mayor Rudy Paco queried of funds allotted to GAIN for additional kennels. Mayors have been doing their part to eradicate strays but storage is another concern.

Mayor Allan Ungacta queried on the inquiry during a meeting months ago of additional cages, proper snares, and PPEs. People who claim these dogs are not theirs yet they feed them.

Mayor Paul McDonald said to return it back to Dept. of Agriculture so they can take care of eliminating stray animals and to revisit the situation in GAIN to make kennels available.

President said there were discussions earlier that DoAG would receive funding for GAIN to build more kennels.

Mayor Savares commented that mayors wait at the mercy of GAIN to allow them to bring the dogs up there. GAIN still limits the number of dogs mayors bring up there. It has costed her office buying dog food. Other options are needed.

MCOG FY2022 BUDGET – Mayor Ernest Chargualaf said he wrote a letter to ED and *President* about the inequity of the VOMBPS distribution and expected a courtesy letter back of a plan of action so he could proceed with an oversight hearing. He reached out to Senator Moylan to see if he could amend and restore it back. During the meetings, *President* had asked mayor to go to the legislature directly to request any change in the policy because it was already signed into law. It was talked about over and over again. Council had public meetings and there was a public hearing about the budget.

Mayor said there were no discussions on the introduction of the VOMBPS and that he should've been given notifications so he could defend himself. *Vice President* stated that it was voted on as a *body* and the decision was reaffirmed. *Vice President* said to check the minutes.

IX. UNFINISHED BUSINESS

1. **FOSTER CARE PROJECT** – *President* thanked the mayors for their participation in the *Belen* contest. There was a tie for second place between Agana Heights and Mongmong-Toto-Maite Mayor's Offices. Because Council didn't receive 16 votes by telephone, *President* stated that he didn't feel it was prudent to make the decision on his own. The first option was to divide or to allow each winner to receive \$1,500.

Mayor Savares made the motion to give each of the second place winners \$1,500 each from the *Dues* account. Seconded by Mayor McDonald. In discussion, Mayor Ernest Chargualaf stated that he sent an email to Council president of his suggestions and never responded. *President* reiterated his statement. No further discussions or objections. The motion carried.

President recognized and gave the floor to Vice Mayor Kevin Delgado who announced that there are now fifteen (15) individuals and families that are up for licensing to become foster families and foster parents. The goal of nineteen (19) wasn't met in December but will continue until the month of May. For a week of advent joy campaign to announce to the different Catholic churches and other faith denominations, a packet was sent to the

Archdiocese of Agana to transmit and forward to all parishes. Unfortunately, they responded that it was overlooked and was never sent out.

In lieu of this, Vice Mayor Delgado will work with Adztech to do a simple write-up about the program and then a prayer they could mention or pray during Valentine's Day weekend, February 12 and 13. This program and activity will be connected to the Catholic Church side.

Both vice mayor and council president continue to work with Mae Fe Muyco at DPHSS. Of the new families and parents, a breakdown was requested from what villages they are from.

X. NEW BUSINESS

ED asked for a council member to make a motion to go back to number three (3) on the *Approval of the Agenda* to include ARPA in New Business.

Mayor Hofmann made the motion to move and seconded by Mayor Savares. No further discussions or objections. The motion carried.

1. **78TH LIBERATION FESTIVITIES** – *President* announced that he will chair and Vice President, Mayor Hofmann will co-chair this standing committee. They plan to bring back the Queen's contest. *President* called for a January 10 meeting at 10 a.m. via Zoom. Because there is no seed money for the printing of tickets it was suggested to use money from the mayors' dues account to front it and reimburse later.

Mayor Savares made the motion to front no more than \$6,000 from the Mayors' Dues account for the printing of tickets and reimburse the account after money had been raised. Seconded by Mayor Ungacta. No further discussions or objections. Motion carried.

2. SENIOR CENTERS REOPENING – Mayor Hofmann made the motion to go back to the *Approval of the Agenda* to include Senior Centers Reopening in New Business. Seconded by Mayor Louise Rivera. No further discussions or objections. Motion carried.

During the emergency meeting of January 3, *President* had mentioned that the notice to postpone the reopening had to come from DPHSS because they recommended in communication with the governor and Physicians Advisory Group. It is not the fault of the mayors. There is no word yet.

Mayor Hofmann expressed that they are prepared to still do what is needed for the manåmko', but it involves transportation resources, the vendor who prepares the food, and the numbers needed to give from the Recreation Leaders for the home-based and center pick-up meal services.

Council hoped to get the final decision today.

3. ARPA FUNDS DISTRIBUTION – Mayor Savares made the motion to move in *Executive Session* to discuss the distribution. Seconded by Mayor June Blas. No further discussions or objections. Motion carried.

Mayor Hofmann made the motion to table the American Rescue plan and take that only point of discussion on Friday. Seconded by Vice Mayor Delgado. No further discussions or objections. The motion carried.

XI. ANNOUNCEMENTS

- ➤ G3 Conservation Corps for the second cohort will begin village cleanup starting February. *President* recommended the same schedule starting with Yigo and work their way down south. The Corps will be contacting the mayors' offices.
- > The new director with the Guam Public Library System wanted to open more days and will be making appointments with mayors that have libraries in their village. The director wants to incorporate activities and programs.
- President asked for a motion to pay the balance of \$450 for the drapery at the conference room from the revolving fund account. Mayor Hofmann made the motion and seconded by Mayor Paco. No further discussions or objections. The motion carried.

XII. RECESS

Mayor Gogue made the motion to recess until 10 a.m. Friday, January 7 to continue discussions for thirty (30) minutes and seconded by Mayor Hofmann. In discussion, Mayor Anthony Chargualaf asked to move the time to 9 a.m. Mayor Gogue amended his motion to move the time to 9 a.m. and seconded by Mayor Hofmann. No further discussions or objections. The motion carried. Recessed at 2:38 p.m.

NEW BUSINESS -

ARPA FUNDS DISTRIBUTION

Options #1 and #3 were distributed January 6.

ED gave review of Option #1 and explained that when he asked for the short fall money in FY21 back in April of 2021, the Council didn't know what the FY 22 budget would be as far as SMB, IWBP, and PSSEP. What was known was that there was a reduction from FY 20 to FY 21, and that reduction was reflected in the amount that he had requested from the governor's office to help MCOG shortfalls in FY 21. MCOG received a new budget in October of 2021, which again, reflected the same amount of money that MCOG received in FY21 except a different formula was used. Option 1 basically just does what FY 21 formula was, which is up to \$20,000 per district and the remaining in SMB is divided pro rata based on the *Roads Pavement Inventory*. IWBP and PSSEP was divided equally. This does not include the Limited Gaming Fund because it wasn't included in the shortfall request that was submitted to the governor's office.

Option #2, the amount of \$892,129 divided equally amongst all villages which came out to \$46,954.15 per village.

Option #3 Using the FY22 Budget formula, each district receives \$20,000 and the remaining balance is divided prorata using the total local road mileage in each village as a percentage of the total road mileage of Guam's Roads Pavement Inventory with the Department of Public Works.

ED clarified that this is not non-entitlement units funding from ARPA. We did not qualify for that designation.
