## **HOW ARE WE DOING?**

### AUDITS

An audit of the FY19 Non –Appropriated Funds (NAF) for each village and the MCoG Revolving Fund is ongoing by OPA for selected villages. The onset of COVID-19 has delayed the completion of these audits. We continue to increase our efforts in the villages to improve their accounting systems. We have also provided education opportunities to Administrative Assistants in the villages to attend procurement courses at the Guam Community College. We will continue to provide opportunities for staff in all 19 villages to undergo Procurement classes at GCC whenever it is available. An NAF Procurement Policy Manual has been established and is now in use by all villages. The NAF funds are mainly made up of funds by the operation of village night markets, flea markets, fiesta celebrations and festivals and corporate donations from business entities.

### VILLAGE GROWTH

A more accurate population of Guam has been conducted for the 2020 Census count but results have also been delayed by the COVID-19 pandemic. However, we have seen growth in individual villages as verified by requests for address verifications and additions of individuals to family rosters at the Mayors' offices. Mangilao and Yigo continue to be the fastest growing villages and this can be attributed to the number of housing developments in the two villages. Dededo, Tamuning, and Sinajana have the most

attendance at the Senior Citizen Centers but all centers have been closed since March 2021 due to the pandemic. The request for new roads to be built for use of Chamorro Land Trust recipients are constant in Dededo, Yigo, Mangilao, Inalåhan, and Humåtak. A breakdown of village office activity from constituents is as follows:

## **SENIOR CENTER/ADULT DAY CARE OPERATIONS**

In FY20, we continued to operate 12 senior centers in 11 villages until March 2021. We continue to operate the centers however to provide food delivery to all registered seniors. We were fortunate to receive \$300,000 in transferred funds from the Office of the Governor to fix or repair immediate needs at the 12 senior centers and 3 adult day care centers. In all, while participation varies on a daily basis from center to center, we provide service to approximately 1485 “active registered” seniors. We also continue the operations of the Adult Day Care Services (ADC) which are located at the ADC North in Yigo, ADC Dededo in the Macheche Community Center, and the ADC South in Inalahan up to March 2021. These services are for seniors who need “special assistance” and are provided Monday to Friday. These programs are operated under the Mayors’ Council of Guam through a Memorandum of Agreement with the Department of Public Health and Social Services. Funding for these operations are detailed under the FY20 Appropriations & Direct Funding section.

We are grateful for the infusion of federal dollars through the Cares Act but bringing our island back to a strong, vibrant economy when our island returns to PCOR4 remains a challenge for all agencies and instrumentalities of our government.

We are optimistic that we will win this war against our invisible enemy COVID-19. We are proud of the many sacrifices and efforts of all our people to defeat this enemy and move forward to an even better, safer, and healthier Guam in the years to come.

## SENIOR CENTER/ADULT DAY CARE OPERATIONS

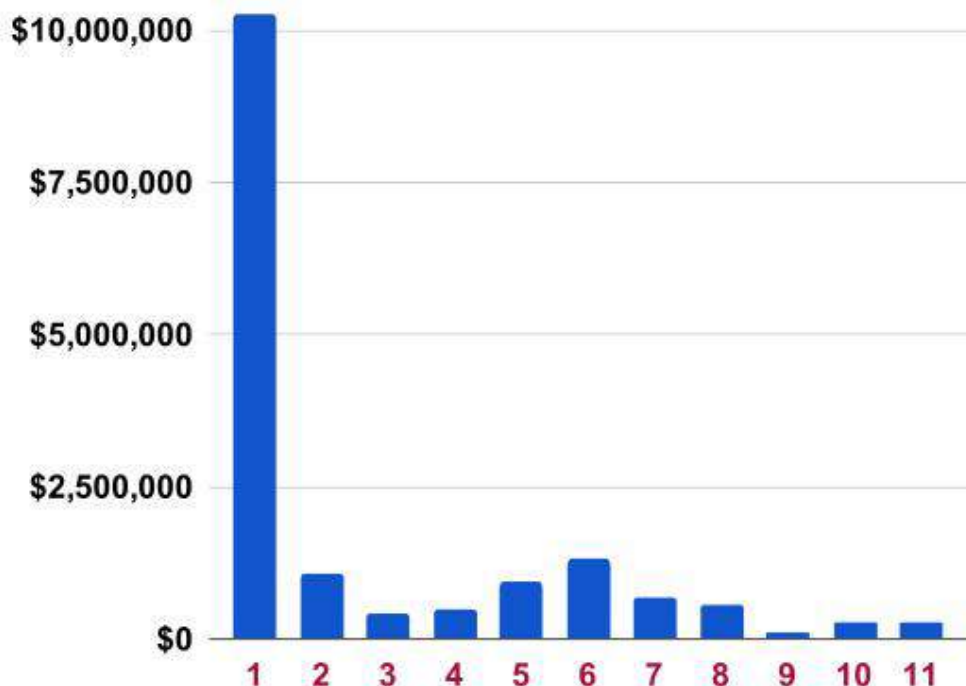
