IV. 001-25	GUEST SPEAKERS — Honorable Presiding Judge Arthur R. Barcinas Juvenile Probation to address Mental Health Community Response represented by Rossana Villagomez Aguon, Mark Mitsuyasu and Felix S. Reyes Western Pacific Regional Fishery Management Council, Christine C. Fejeran, Forestry Division Chief — Guam Dept. of Agriculture, Forestry & Soil Resources Division, Dr. Mariana Turner, Territorial Veterinarian — Guam Department of Agriculture, Animal Health Division
A.	Honorable Judge Barcinas was unable to attend due to his court calendar for this day. Mrs. Rosanna Villagomez Aguon, Chief Probation Officer at the Judiciary of Guam presents the discussion on Survey Responses and Community Engagement on behalf of Honorable Judge Barcinas. Judge Barcinas wanted to address the juvenile justice system and family engagement committee. The committee aims to inventory community resources, identify gaps, and augment family engagement in court proceedings. A survey was sent to various stakeholders, including mayors, to gather information on available services and programs. Rosanna Villagomez Aguon announces there were only five responses from the Mayors. Rosanna Villagomez mentions that some new mayors have responded, but many have not. Mayor Hofmann inquires about the five villages that responded to the survey. Rosanna Villagomez lists the villages: Sinajana, Piti, Hagatna, Chalan Pago-Ordot, and Barrigada. The President and Rosanna Villagomez discuss the importance of filling out the survey and the benefits of community
В.	engagement.  The President introduces Felix Reyes from the Western Pacific Regional Fishery Management Council.
	Felix Reyes introduces Mr. Mark Mitsuyasu, who will explain the council's activities. Mr. Mark Mitsuyasu provides an overview of the council's jurisdiction, purpose, and primary activities. The council receives funding to support projects related to climate change and fishery management. Mr. Mark Mitsuyasu discusses four projects the council is kicking off, including scenario planning, regulatory review, protected species interactions, and community engagement. The council plans to engage with local communities to understand the impacts of climate change on fisheries. Mr. Mark Mitsuyasu mentions upcoming meetings in various locations to gather community input. Contact information for the council and staff is provided, and Mr. Mark Mitsuyasu invites questions.  The President recognizes Executive Director Joy Jean, who asks about assistance for reviving Pago Bay for fishing.  Mr. Mark Mitsuyasu explains the council's focus on military impacts and development on offshore fisheries and local community initiatives.
	Executive Director Joy Jean inquires about available grants for community initiatives.

	Mr. Mark Mitsuyasu mentions various opportunities and the importance of aligning with the council's priorities.
C.	The President introduces Christine Fejeran, the Forestry Division Chief for the Guam Department of Agriculture.
	Christine Fejeran introduces her team and their roles in urban and
	community forestry, landscape-scale restoration, and fire management.
	Christine Fejeran emphasizes the importance of community engagement
	and collaboration in forestry efforts. The team has implemented various
	programs and initiatives to address forest health, fire prevention, and
	community outreach. Christine Fejeran highlights the importance of tree
	cutting permits and proper tree maintenance.
	Mayor Louise inquires about the schedule for trimming shrubs along Route1.
	Christine Fejeran suggests coordinating inspections and tree work to
	ensure efficient and effective maintenance.
	Executive Director Joy Jean asks about mitigating tree roots damaging
	roads, and Christine Fejeran explains the importance of proper tree
	pruning.
D.	Dr. Turner introduces herself and discusses the stray dog issue in Guam.
	The initial survey in 2014 estimated 24,000 free-roaming dogs and the
	current survey is pending. Dr. Turner emphasizes the need for collaboration between animal control officers and village staff to address
	the issue. A training session on handling free-roaming dogs safely and
	humanely is scheduled for March 10.
	Bill Bennett presents on the history and benefits of the village baseball
	program. GABA has been organizing various baseball and softball
	programs for youth and adults. The pilot program in July was successful,
	and the program aims to bring back adult baseball to Paseo Stadium. The
	President and the mayors discuss the importance of organizing teams and
	finding coaches for the league.

VII. 004-25	EXECUTIVE DIRECTOR'S REPORT – Joy Jean R. Arceo
A.	The Executive Director announced that the day to day operations training held
	on February 12 and 13, 2025 was a success and notified that the meeting
	originally scheduled for February 20, 2025 is now scheduled for March 13,
	2025 that will cover the remaining villages who have not been trained.

В.	The Executive Director announced an email was sent out on February 10, 2025 requesting submission of the annual average expense budget submission and thanks the villages who have submitted their report.	
C.	The Executive Director announced that the procurement method for invitation for bid regarding the recycling revolving fund program has been identified. The abandoned vehicle has been packaged and the planning/drafting phase is ready for signature and once completed will be	
	sent to the Attorney General's office for review.	
	The executive director reports on the status of the supplemental budget and	
	the need for accurate financial information.	
	The President mentions the submission due date of March 27 from the	
	Mayor's Council and the need for averages to develop the budget. Mayor	
	Quinata raises concerns about running out of fuel for village operations,	
	particularly for grass cutting.	
	Executive Director Joy Jean emphasizes the importance of having sufficient	
	funding before signing off on expenditures.	

VIII. 005-25	COMMITTEE REPORTS	
A.	A. <b>Boards and Commissions</b> –The President moves on to committee reports,	
	starting with the Commission on Decolonization, which has no report at this	
	time.	
1. (a)	Mayor Louise Rivera discusses the need to convert Chief Brodie Memorial	
	School to a middle school, citing a board meeting where the conversion was	
	approved. Mayor Louise highlights the long-standing need for a middle	
	school in the area and the board's approval of the redistricting and	
	conversion.	
(b)	The President announces a motion to support the conversion, A motion was	
	made by Mayor Rivera which is seconded by the Vice Mayor Albert Toves.	
	Mayor Peter Benavente agrees to bring up the situation in the next meeting	
	with the board for more details.	
	Mayor Terlaje raises concerns about the no credit policy and technical	
	absence policy in high schools, which teachers find frustrating and asks	
	Mayor Benavente to bring it up to the Education policy board.	
	Mayor Alvarez suggests investing in security cameras for schools, citing a	
	recent incident at Truman Elementary.	
	The President acknowledges the need for a solution to the grass cutting issue	
	and mentions a 90-day emergency procurement for grass cutting.	
	Mayor Hofmann emphasizes the importance of responding to the park	
	conditions survey to help improve park facilities.	
	The President asks for updates from the Guam Regional Transit Authority	
	and GVB, but no reports are provided. Mayor Hofmann mentions the park	
	conditions survey and the importance of responding to it to help improve	
	park facilities. The President emphasizes the need for villages to respond to	
	the survey to help create a data set for improving park conditions.	

Mayor Hofmann highlights the need for better maintenance and cleaning of parks and facilities.

IX. 006-25	UNFINISHED BUSINESS
A. The President discusses the legal requirements for conducting fu	
	escorts, including the need for authorization from the chief of police. The
	President informs the council that the Mayor's Council will not be
	coordinating funeral escorts due to legal and training issues.
B.	The President moves on to the MCOG budget, emphasizing the need for
	averages for fiscal 26 and the inclusion of feral pig management in the
	budget. The President mentions the need to adjust staffing patterns and
	salaries within offices and the central office.
C.	The President discusses the Liberation Day Queen Coronation, mentioning
	the need for a thorough explanation of the new requirements. The
	President emphasizes the importance of not printing tickets and allowing
	candidates to fundraise for their participation. The President calls for a
	decision on the final draft of the new rules and regulations by the April
	meeting. The President mentions the need for every mayor and vice mayor
	to receive a copy of the final draft for review.
D.	The President calls for a report on the 31st AMIM General Assembly,
	emphasizing the need for productive participation. The President mentions
	the upcoming exchange in May and the need to develop criteria for
	selecting students from Guam.
